## Spring 2018

Spring of 2018 is here. Let's hope this is a normal summer on the river for a change. We had a wicked ice jam this winter. Some residents lost their docks and others had damage because of it. If that wasn't bad enough it was followed up by a moderate flood. Water levels went a few inches higher than last summer's flood. The flood occurred due to rapid water run off due to the ground being frozen and snow melt. The poor people of Freeport saw the worst. It would appear that FEMA needs to start buying up some of the homes in the floodplain there, like they have been doing in Machesney Park.

There is still a problem with our Dam in Rockford. Gate 1 is still broken. In November of 2016 Com-Ed hired a contractor to raise the gate halfway open and put turnbuckles on to keep it at this position. They know it is broken and this was their temporary solution until it could be repaired properly. Well, it's been a year and a half and they are making no plans to do the repairs. Their permit says they are responsible for upkeep and repairs of the dam for as long as they own it. They have come to the realization no one wants it. It's time for them to do what is needed to bring it back to working order. We have had 2 MAJOR floods with a broken dam so far. What this means is we are only discharging 87.5% of the water. We deserve to have a functional dam that operates at 100% discharge during a flood. This is what the permit says it should be doing at peak flood. On the other end of the equation in late summer when the dam is supposed to hold back water to maintain our recreational pool water level 12.5% of our water is being drained due to the broken gate being stuck in the halfway open position.

ENOUGH IS ENOUGH! I remember a Com-Ed commercial a few years back when they said Com-Ed cares about the local community. If this is true, it's time for them to put their money where their mouth is. A broken dam affects the entire community. From River residences and River businesses, to weekend boaters and the sales tax revenue they generate. Our goal is to generate thousands of phone calls and emails to local government officials to let our voice be heard. The dam needs repairs now, before the other 3 gates fail and compound our flooding and drought conditions more.

The toll free number for Com-Ed is 800-344-7661. Please call them and let them know they are responsible for the dam and it's time to fix it before it gets worse. Please call all 3 Mayors also. Mayor Tom McNamara from Rockford 779-348-7300, Greg Jury from Loves Park, 815-654-5030 and Steve Johnson from Machesney Park 815-877-5432, to ask for their help in getting the dam repaired. Also include Senator Dave Severson 815-987-7555 and State Representative John Cabello 815-282-0083.

Besides a broken gate, the high and low water alarms do not work. The only alarm that works is a phone call from the Rock River Home Owners telling them of problems with high or low water levels at the dam requiring immediate attention. To better educate you to conditions at the dam, there is a new website that has been set up. Www.BrokenDamRockford.com. Please visit the site and navigate through the information available. The media gallery tab has drone footage pictures and video taken during the peak of the flood. You will be able to see the 3 working gates fully open discharging water and the broken gate holding back the flood water it was designed to be full open at flood and it only half open. Back in the 70's when the dam was rebuilt, it could be run from the Joliet Illinois control center. This is no longer the case. They must send an area operator out to the dam and manually open or close the gates as needed. During a flood, this needs to be done twice a day to maintain the 2.5' above sea level their permit says the water level should be kept at. We are lucky to get them there once every 2 or 3 days sometimes. If you don't call and voice your concerns and discontent with their poor maintenance procedures, nothing will get done. Tell your friends and neighbors to take 2 minutes and call Com-Ed at 800-344-7661. Let's get our dam repaired NOW, not next year or next decade!

Safety Sticker. The Auxiliary also can hold boat safety classes, contact the website for where they are held and dates. A note to keep in mind is that paddle craft are becoming increasingly popular and this means watching out for them and their safety. They are also a high risk due to their size and easily capsizing. We hope beginners and experts alike all wear their floatation while operating them.

#### Past and Present Rock River Homeowners Association Projects

If you're wondering where your dues and other donation monies are being used to improve our Rock River, here are just a few of the completed and on going Rock River improvements your association has accomplished! (Not in any specific order!)

- 1. Installed commercial marine navigational solar lights on bridges and maintain with new bulbs and batteries when needed. If you boat at night, these are a great help to see what pass to use and where the supports are.
- 2. Installed directional arrow navigation signs on the bridges to help guide boat traffic under bridges.
- 3. Purchased additional buoys for no wake and hazard areas and installed flashing lights on them.
- 4. Purchased a new Bimini shade top for the Sherriff's patrol boat.
- 5. Installed and maintain news and information stations at launch areas.
- 6. Installed navigation solar light for entry to Sports Core launch on shore.
- 7. Construction and installation of a static river level gauge at Davis Park in 2014.
- 8. Purchase and installation of an official U.S.G.S electronic gauge at Davis Park at the dam for spring of 2015, this will be of great importance to everyone viewing the water level gauges on the website, as it will give the level <u>at the dam</u>.
- 9. Create and maintain a professional Website that shows all area river gauges in one page, and other important Rock River information to home owners and boaters.
- 10. Donate money to the Ski Broncs yearly for their program to further the Rock River's value as an entertainment venue.
- 11. Publication of the Rock River Homeowners Association Newsletter to keep homeowners and businesses on the river informed.
- 12. Support by board members and homeowners by volunteering during Rock River cleanup events like Rock River Sweep.
- 13. Removal of trees to safer areas after flooding.
- 14. No wake signs at boat launches during high water and flooding.
- 15. Do you have a project you'd like to see addressed? Send us a note or call any of the board members!

#### Forest City Queen Fundraiser

#### **BRIDGE NAVIGATIONAL HEIGHT SIGNS**

When you're navigating up or down the river and going under the various bridges, look for the "Arrow" signs on North and south areas of the bridges, for the best boat navigation under the bridge. The preferred space between the pylons will be marked with Arrow signs, and under some of the lower bridges, a "TALL" sign will guide you

If you have lost your pier or dock sections, please go to our facebook page, Rock River Home Owners Association, where you can post a photo of your lost or found dock. We have helped a few people locate theirs this way. Be sure to have your name and address on your dock sections if you haven't already to help identify them when so many are similar looking. You can also add some color to the sides if that would help also. Most docks are tied up after removal in the fall, but swift flood waters can break them loose, so being able to identify them is key. We've seen whole boat lifts get carried downstream for blocks during a flood and the only way to find them is to use a locator.




